

**ORDINANCE NO. 38-2018**

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY AUTHORIZING THE RESURFACING THREE (3) TENNIS COURTS WITH RELATED TENNIS COURT APPURTENANCES AT MALAPARDIS PARK IN THE CEDAR KNOLLS SECTION OF THE TOWNSHIP AND FURTHER APPROPRIATING THE SUM OF \$70,000.00 FROM THE TOWNSHIP'S 2018 CURRENT FUND BUDGET FOR THE FINANCING OF THE PROJECT**

**WHEREAS**, the Board of Recreation Commissioners of the Township of Hanover has requested certain improvements and amenities to Malapardis Park in the Cedar Knolls Section of the Township; and

**WHEREAS**, the Township Committee has reviewed the proposed project and concurs with the Board that the continual maintenance and improvement to Malapardis Park is essential in order to maintain its integrity and reliability as a fully functional and operational amenity for residents.

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Hanover, in the County of Morris and State of New Jersey as follows:

**Section 1.** The governing body hereby authorizes and approves the following capital improvement project at Malapardis Park:

Resurfacing three (3) tennis courts with related tennis court appurtenances.

**Section 2.** The Township Engineer and Assistant Township Engineer are authorized and directed to prepare the necessary plans, specifications and bid documents to be utilized in connection with the resurfacing of the three (3) tennis courts including related appurtenances as described in **Section 1**. Above and to publicly advertise and receive sealed competitive bids, all in accordance with the Local Public Contracts Law at N.J.S.A. 40A:11-1 et seq.

**Section 3.** There is hereby appropriated the sum of \$70,000.00 to furnish and install the improvements as described in **Section 1**. of this Ordinance from the following account:

**Section 4.** All ordinances of the Township of Hanover, which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.


