

ORDINANCE NO. 12-2020

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER AMENDING AND SUPPLEMENTING ORDINANCE NO. 1-2020 AND SECTION 125-4. ENTITLED "RECREATION DEPARTMENT FEES" UNDER CHAPTER 125 OF THE CODE OF THE TOWNSHIP ENTITLED FEES WITH THE INCLUSION OF NEW FEES FOR VARIOUS RECREATION AND PARK ADMINISTRATION PROGRAMS AND ACTIVITIES

WHEREAS, the Board of Recreation Commissioners, during its February 18, 2020 regular meeting approved new fees for the Summer Plus 2020, Travelling Teams, Youth Public Safety Academy, Summer Sports Clinics, Wildcat Sports Camps and Counselor In-House Training Program sponsored by the Township's Recreation and Park Administration Department; and

WHEREAS, in a memorandum dated February 24, 2020 to the Mayor and Township Committee, the Superintendent of the Recreation and Park Administration Department, in accordance with the recommendations of the Board of Recreation Commissioners, submitted a list of the revised program fees for the various programs and activities listed in Section 1. below as sponsored by the Department; and

WHEREAS, the memorandum of the Superintendent of the Recreation and Park Administration Department dated February 24, 2020 are incorporated herein and made a part of this Ordinance as if set forth in full.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

Section 1. §125-4. Entitled "Recreation Department Fees." Under Chapter 125 of the Code of the Township entitled Fees is hereby amended and supplemented with the inclusion of new fees for the programs and activities set forth below:


Section 3. All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, hereby repealed.
