ORDINANCE NO. 41-2018

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY AUTHORIZING THE DEMOLITION OF SINGLE STORY GARAGE LOCATED AT 370 WHIPPANY ROAD IN WHIPPANY AND ALSO DESIGNATED AS LOT 1 IN BLOCK 2006 AS SET FORTH ON THE TAX MAP OF THE TOWNSHIP OF HANOVER AND FURTHER APPROPRIATING THE SUM OF \$30,000.00 FROM THE TOWNSHIP'S 2018 CURRENT FUND BUDGET FOR THE FINANCING OF THE PROJECT

WHEREAS, the Township owns a tract of land identified as 370 Whippany Road in the Whippany Section of the Township and also designated as Lot 1 in Block 2006 as set forth on the Tax Map of the Township of Hanover containing a single story garage used for storage by the Department of Public Works, Buildings and Grounds and Park Maintenance (DPW); and

WHEREAS, the garage is in serious disrepair and has outlived its useful purpose; and

WHEREAS, the garage is no longer needed for storage by the DPW.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hanover, in the County of Morris and State of New Jersey as follows:

<u>Section 1.</u> The governing body hereby authorizes and approves the demolition of the single story garage located at 370 Whippany Road in Whippany and also designated as Lot 1 in Block 2006 as set forth on the Tax Map of the Township of Hanover.

<u>Section 2.</u> The Township Engineer and/or the Assistant Township Engineer are authorized and directed to prepare the necessary drawings, plans and specifications for the demolition of the garage.

<u>Section 3.</u> In accordance with the drawings, plans and specifications, the Township Engineer and/or Assistant Township Engineer are authorized and directed to advertise for the receipt of sealed competitive bids for the demolition set forth in <u>Section 1.</u> above, all in accordance with the Local Public Contracts Law at N.J.S.A. 40A:11-1 et seq.

<u>Section 4.</u> There is hereby appropriated the sum of \$30,000.00 to perform the demolition as described in <u>Section 1.</u> of this Ordinance from the following account:

<u>Section 5.</u> All ordinances of the Township of Hanover, which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

<u>Section 6.</u> If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this ordinance.

Section 7. This Ordinance shall take effect in accordance with law.
